KWA PWS COMMITTEE:

John Bailey & Nathan Westrup gave a presentation for the Public Water Supply (PWS) Committee and what goes into considering Water Purchasing Contracts.

Water Purchasing Contract 22-1

Motion No. 08-17-02 It was moved by **John Bailey** and seconded by **Lynn Goossen** to approve Water

Purchasing Contract 22-1 with the City of Independence. Motion carried with no

dissenting votes. Information found in meeting materials.

Nathan Westrup then presented on the Water Marking Program's Comprehensive Capital

Development plan.

Dawn Buehler opened the floor for discussion. Comment was made that the

Comprehensive Capital Development plan is intended to be in place for the CY24 rate

discussions.

Jay Kalbas introduced himself to the Kansas Water Authority as the new Director of the

Kansas Geological Survey.

KANSAS WATER PLAN: Connie Owen started the discussion on the Kansas Water Plan. Reminded the

room that approval of the Kansas Water Plan was subject to editorial edits. Connie

then opened the floor for discussion.

Items that were discussed:

Adding wording to the document that recommends accountability. A

formal process will be initiated to create specific targets, metrics and goals to implement recommendations in this section through a collaborative process through state agencies, regional advisory committees, local stakeholders, and the Kansas Water Office.

- Adding Bill Golden's work in the Aquifer guiding principles. Adding wording that talks more specially about professor Golden's work.
- Making a section that talks about incentives of using less water from the aquifer
- Adding chemicals specific to water producers to the either the surface water or water quality sections - Leo Henning to provide wording
- Being more direct and firm about funding issues
- Adding the Equus Beds to the Aquifer section
- Adjusting wording for the Aquifer section. Reservoir section is listed as "Conserve, protect, and restore reservoirs." Should we change the Aquifer Section to something similar?
- Adjustment of wording or creation of a committee to consider sustainability as part of the guiding principals in addressing the conservation of the High Plains Aquifer.
- Working on more practices that reduce sediment as dredging is a short-term solution. If all we do is dredge will the supply be able to keep pace with the population growth?
- Kansas Corporation Commission opportunities to provide remediation support of the salt bloom in the Equus Beds.
- Making it more explicit that this is in fact a planning document and not an implementation document.
- Encouraging legislation to make conservation plans a requirement for all municipal water suppliers

Approval of the 2022 Kansas Water Plan

Motion 08-17-03

It was moved by <u>Jean Steiner</u> and seconded by <u>Jeremiah Hobbs</u> to approve the 2022 Kansas Water Plan subject to editorial changes and with the addition the following items. **Motion carried with no dissenting votes.** Information found in meeting materials.

- 1. Add as a recommendation to the guiding principles:
 - a. "A formal process will be initiated to create specific targets, metrics and goals to implement recommendations in this section through a collaborative process involving state agencies, regional advisory committees, local stakeholders, groundwater management districts, and the Kansas Water Authority"
 - b. "The Kansas Water Authority shall create a committee to consider sustainability as part of the Guiding Principle addressing the Ogallala Aquifer."
 - c. "Educate producers on the increased profitability that can be achieved through reduced groundwater usage, as documented in Professor Bill Golden's economic analyses."
- 2. Add a reference to Professor Bill Golden's research.
- 3. Add the following language to the Water Quality Section:
 - a. "Nitrates, phosphorus. Atrazine, bromides, uranium, chlorides, and other contaminates are impacting surface water quality. The Kansas

Water plan will continue to promote activities and fining to address and reduce the impacts to surface water quality."

KWA BUDGET COMMITTEE:

<u>Michael Armstrong</u> presented on the FY 2024 budget. Then, <u>Matt Unruh</u> presented on the FY 2024 State Water Plan Fund budget.

<u>Dawn Buehler</u> opened the floor for discussion. Discussion was had about every agency's enhancements.

Items Proposed for Action:

- Consider approval of negotiated amendment to Water Purchase Contract No. 17-2
- Consider recommendation of the committee to encourage the Director to send a letter to the U.S. Army Corps of Engineers asking for a Public Assistance to States (PAS) study targeting potential technical approaches to managing sediment and achieving sustainability of federal reservoirs in Kansas.

Evergy has requested an extension of Water Purchase Contract (WPC) No. 17-2, the supplemental water supply for Wolf Creek Nuclear Generating Station. The source of supply for WPC No. 17-2 is John Redmond Reservoir and it is the sole source of make-up water for the power plant's cooling lake.

Water Marketing Contract No. 17-2

- o Original Term of 5 years (maximum 40)
- o Expires 12/31/22
- o Quantity: 9,368 MGY

Negotiated amendment


- o Article 2, extend contract term from 5 years to 10 years (Expiration 12/31/2027)
- o Article 6(b), statute requires quantity review on the sixth anniversary
- Amend names of the Purchaser entities

The Public Water Supply Committee recommends approval of the negotiated amendment for Water Purchase Contract, No. 17-2

Drought: Status and reservoir operations

The committee was briefed on the most recent county drought declarations and outlooks. The seasonal outlooks are predicting persistence and further development throughout the state.

The predominant flow in the Kansas River, Marais des Cygnes River, Verdigris River, and Neosho River basins is water released from storage. Operations have been activated in all water assurance districts and Water Marketing Program customer demands are being supported.



Capital Development Plan – Water Marketing Program fiscal policy

The committee continued the review Water Marketing Program financial forecasts and some initial thoughts on developing parameters of fiscal policy related to revenue generation in excess of basic expenses. Some of the critical fiscal policies to be developed will require additional information, such as estimates of future expenses related to reservoir sediment management.

The KWO has been pursuing identification of sediment management technologies (such as WID) but has not been able to develop the protection and restoration Master Plan, referenced in the 2017 Public Water Supply Comprehensive Capital Development Plan. The committee is supportive of generating revenue for research and development of innovative in-lake sediment management technologies through cost share studies with the U.S. Army Corps of Engineers.

The KWA Public Water Supply Committee recommends to the full Kansas Water Authority that the KWA encourage the Director of the Kansas Water Office to send a letter to the U.S. Army Corps of Engineers asking for a Public Assistance to States (PAS) study targeting potential technical approaches to managing sediment and achieving sustainability of federal reservoirs in Kansas.

AMENDMENT TO WATER PURCHASE CONTRACT NO. 17-2

a. Pursuant to the authority of Article 15 of Water Purchase Contract Number 17-2, the parties

agree to extend the term of this contract for an additional period of five (5) years. To extend the term by an

additional five (5) years, the parties agree to modify the termination date in Article 2 to state that the contract

will terminate on the 31st day of December 2027.

b. The names of two of the Purchaser entities has changed. All contract references to the entity

formerly known as Kansas Gas and Electric Company shall be replaced with the new entity name Evergy

Kansas Central, Inc. All contract references to the entity formerly known as Kansas City Power & Light

Company shall be replaced with the new entity name Evergy Metro, Inc.

c. The parties also agree that because this contract is being extended beyond its initial five (5) year term,

paragraph (b) of Article 6 shall be replaced with the following language: "Pursuant to the provisions provided

under K.S.A. 82a-1306(a)(4), the Director may adjust the total amount of water contracted for on the sixth

anniversary of the execution of the contract and on each annual anniversary thereafter, if the Purchaser does not

begin full payment for the water under contract and another water user is ready, willing, and able to contract for

such water."

The KWA Regional Advisory Committee (RAC) Operations Committee met October 17, 2022, via GoTo Meeting. Discussion during the conference call focused on the following topics:

• Membership continuation for the Solomon-Republican Regional Advisory Committee.

The Committee reviewed and discussed the continuation to serve as a Solomon-Republican RAC member for Keli Habiger due to her recent move to Nebraska. The following items were taken into consideration for the approval to continue representation:

Keli Habiger's 2019 application and activity serving on the Solomon-Republican RAC in the Fish, Wildlife & Recreation category
 Review of the RAC Structure and Membership policy, Category Number 5:

Applicants are eligible for committee membership only in the region in which they have their primary place of residence. At the discretion of the KWA, a member may serve on a regional committee in which they have their place of employment, provided the employment is closely connected to the water user category which they would represent.

- The RAC Operations Committee discussed Ms. Habiger's current employment as a banker in Norton County as their agricultural business lender and the relevancy of that employment to the RAC membership category. It was noted that she had worked for the Post Rock Rural Water District as their superintendent of finance and administration for 8 years, she served on the Secure Sebelius Lake committee, as well as having assisted in the development of the Almena Irrigation agreement with Norton County Community Foundation. It was also discussed that finding RAC members, especially ones that fit the Fish, Wildlife & Recreation category can be difficult at times and that her membership has only one year left before the membership drive will take place.
- Recommend Keli Habiger be considered to continue to represent as a Solomon-Republican RAC member for the *Fish*, *Wildlife & Recreation* category with a term expiration of June 2023.

There are up to three potential agreements between the KWO and U.S. Army Corps of Engineers (USACE) for review and consideration by the Kansas Water Authority (KWA). Approval by the KWA, under KSA 74-2622, is required before the Kansas Water Office (KWO) enters into agreements with the federal government.

Several research projects that currently receive state funding through Reservoir and Water Quality Research (Research Coordination Workgroup) and Assessment and Evaluation have been identified as potentially eligible to receive federal match through Planning Assistance to States (PAS) agreements with USACE.

- Kansas River Alluvial Aquifer Observation Well Network Maintenance and Modeling
- Streambank Evaluation of the Cottonwood and Neosho Rivers above John Redmond Reservoir
- Sediment Coring for HAB Trends at Tuttle and Waconda Reservoirs
- Evaluating Long-Term HAB Trends at Wilson and Kirwin Reservoirs
- Kansas Real-Time Flood Inundation Mapping Tool Development
- KWO Bathymetry

The KWO is working with USACE to scope proposals for one to three PAS agreements and determine which KWO projects would be appropriate in each. The federal contribution is still being determined, but is anticipated to be related to reservoir sustainability and water quality as well. The expected KWO contribution in SFY 2023/24 is up to approximately \$800,000. The final scope, cost, and number of agreements will be determined after further discussions with USACE.

The Kansas Water Office recommends the KWA give approval to the Director to enter into PAS agreement(s) with the U.S. Army Corps of Engineers for Reservoir Sustainability and Water Quality.
