

City of Emporia, Negotiated Contract

- Water Purchase Contract No. 23-5
 - Terms of renewal/enhancement
 - Quantity, 2,281 MGY (increase of 1,186 MGY)
 - Modeled water supply releases needed to supplement natural flows for a projected demand of 3,500 MGY
 - Term: 22.2 years (ending 12/31/2045)
 - Variable rate (previously capped at 10 cents / 1,000 gallons)
 - Withdrawal (release) and re-diversion at downstream intake (no change)
 - Place of use, refined but no substantive change
 - Standard contract, with one exception
 - Article 6b standard statutorily required article (Review and Adjustment), but additional language providing guidance for justification of contract quantity adjustment



City of Coffeyville, Negotiated Contract

- Water Purchase Contract No. 23-6
 - Terms of renewal/enhancement
 - Quantity, 500 MGY (200 MGY increase)
 - Modeled water supply releases needed to supplement natural flows for "current" demand of 1,500 MGY are 498 MGY (YOR is 1956)
 - Term: 10 years
 - Commission resolution specifies, period to not exceed 10 years
 - Variable rate (previously capped at 10 cents / 1,000 gallons)
 - Withdrawal (release) and re-diversion at downstream intake (no change)
 - Place of use, refined and added Caney, KS (small user)
 - Standard contract



- Water Purchase Contract No. 23-8
 - Terms of new contract
 - Quantity, 200 MGY
 - Modeled water supply releases needed to supplement natural flows for "current" demand of 844 MGY are 369 MGY (YOR is 1956)
 - Term: 5 years
 - Some apprehension about commitment to longer term due to the justification based on new industrial customer
 - Variable rate
 - Withdrawal (release) and re-diversion at downstream intake
 - Place of use, refined and added Montgomery Co. RWD No. 6
 - Standard contract










COTTONWOOD & NEOSHO RIVER DROUGHT IMPACTS: CURRENT RESERVOIR STORAGE










U.S. Seasonal Drought Outlook Drought Tendency During the Valid Period
