

- 1. Welcome and Introductions: Chair Berry Bortz welcomed those in attendance to the meeting.
- **2. Regional Advisory Committee (RAC) Approval of Agenda:** Verbal concurrence of approval was given on the agenda as presented with the item 6. Reduced Water Use and Property Values moved to item 3.

Berry noted three major issues are the Hays Transfer, Impairment at Quivira and Sustainability by 2025.

- **3. Reduced Water Use and Property Values** (Roger Hamm, Kansas Department of Revenue): Roger provided an overview of property taxes with emphasis on agricultural and irrigated land valuation and associated taxes. (Handout provided.) Unlike anything else in Kansas, agricultural land value is based on productivity/revenue rather than market value. Roger provided examples of irrigated land reductions on county tax income. Discussion included the variability and complexity of agricultural land taxes.
- **4. Regional Advisory Committee (RAC) Approval of July 2016 Meeting Notes:** Keith Miller made the motion to approve the February 2017 meeting notes with spelling corrections, seconded by Orrin Feril. The motion carried.
- **5. KWA Update:** KWA Update: Chair Berry Bortz and Matt Unruh (KWO) provided an update of the May 2017 KWA meeting which took place in Garden City. A tour of a water technology farm, Garden City utilities, view of the under construction dairy processing plant, wind tower storage facility and components of irrigation ditches near Lakin took place in conjunction with this KWA meeting. Regional Goal Action plans activities from in the Upper Republican, Upper Smoky Hill, Solomon-Republican, Upper Arkansas, Cimarron, and Red Hills regions presented to the KWA and discussed. Berry noted questions on how the RACs were implementing work on their goals generated discussion on the role of RACs, previously defined as advisory. Of particular relevance to the Great Bend Prairie (GBP) was a discussion of funding for a small feed wheat research project at KSU.

Also addressed by KWA was a legislative proposal to use water related fees for education.

RAC discussion indicated a need for KWA to define the RAC role if it different from the RAC Expectation Presentation provided to them in the fall of 2015.

6. Regional Activities

- a. Update on Lower Quality Water Summit: Matt Unruh reviewed the participants and agenda for the July 18, 2017 meeting in Hutchinson. It is hoped the RACs can collaborate on similar goals. All are encouraged to attend.
- b. KCC Oil & Gas Advisory Committee Meeting Update: Scott Alberg reported that the KCC Oil and Gas Advisory Committee is aware of questions related to salt water pipeline location. There will be KCC staff at the Low Quality Water Summit with information on statute or rules needed in this regard. They will also have general information KCC and problems sites.
- c. Feed Wheat Update: already discussed under KWA report.
- d. KDA-Division of Conservation (DOC) FY18 County Allocations: Rob Reschke reviewed DOC's role as an implementer of the State Water Plan and county allocations for fiscal year 2018 for counties in the region. He noted the importance of conservation districts basing their programs on current conditions and plans such as Kansas integrated Water Quality Assessments, WRAPS 9 Element Plans and County NPS plans.

Discussion requested information from DOC to include a summary of watershed district coverage, watershed structures and where additional watershed districts could be developed.

The following motion was made by John Sweet, seconded by Jeremiah Hobbs, and approved by the RAC: The KWO coordinate a meeting of public water supply (PWS) category RAC members to look at PWS goals statewide.

7. Other Business

a. Agency reports on items not previously discussed:

KDA-DWR: Jeff Lanterman reported that DWR modelers are working on regional data on sustainability. When complete, the Chief Engineer would like to meet with the RAC. Maps of some the following data were provided.

- Average reported water use 1993-2015 by township
- Current maximum authorized quantity (acre-feet) of groundwater diversion by township
- Average reported surface water use (1993-2015) by township
- Current maximum authorized quantity (acre-feet) of surface water diversion by township

Natural Resource Conservation Service (NRCS): Erin Batman, Rita Schartz and Monty Brenman discussed the current Environmental Quality Incentives Program (EQIP) program, offered RAC participation in the State Technical Committee and encouraged work with county conservation districts to have programs available to help meet goals.

The Nature Conservancy (TNC): Heidi Mehl provided an overview of a proposal for a USDA Grant titled "Increasing water use efficiency to improve resiliency of communities, agriculture, and natural systems in a water-stressed food production area of Central Kansas".

Representative Greg Lewis outlined the 2017 legislative session discussion and controversy for funding the State Water Plan. He noted that for the first time since 2008 some of the state general fund transfer was approved. Overall the legislators do not favor a sales tax but trend towards something water related to fund the State Water Plan.

b. RAC Membership

- i. Expiring terms and anticipated vacancies were reviewed by Matt Unruh. Appointment to the RAC is by KWA, so no formal action is needed from the RAC. However RAC members should encourage applicants and forward contacts for assistance in applying. Many organizations have been notified of the search for applicants.
- ii. Vice Chair Position: Appointments of vice chairs for all RAC have been made. Keith Miller has agreed to serve as vice chair on the GBP. Vice chairs may be called upon to run meetings or represent the RAC when the Chair is unable to do so.
- c. Questions and Future Issues from Members: None noted
- d. <u>Messages to the Kansas Water Authority:</u> The following motion was made by John Sweet, seconded by Orrin Feril, and approved by the RAC: The GBP RAC respectfully requests KWA provide clarity on the RAC Role in Implementation.
