On behalf of the Kansas Water Authority (KWA), this memo is to acknowledge receipt of the message received from the Missouri Regional Advisory Committee and to provide a response to that message. The KWA met on December 12, and approved the response provided below.

#### **RAC Message:**

The Missouri RAC requests funding to complete Phase II of "Addressing Groundwater Goals of the Missouri Regional Planning Area" by the Kansas Geological Survey (KGS). Funding of the study would provide information directly related to Goals #1 & #3.

### **KWA Response:**

The Kansas Water Authority recognizes the value of projects such as these and appreciates the input of the RACs can provide for the priority project development process for the State Water Plan funding. RACs providing input to the KWA and KWO on these types of projects is a great way for the RACs to continue to engage in the RAC Action Plan implementation process by providing information on annual projects which should be considered for funding. The KWA would like KWO to coordinate with the RACs earlier in the budget development process in future years to review and provide input on the projects identified by the KWO as priority projects to be considered for funding for inclusion within the KWA's budget requests. KWO Regional Planners shall also provide budget overview information to the RACs on the current State Water Plan expenditures and where those funds are currently being spent.

- talked about the number of legislators that were there and the ability to network with individuals at the conference.
- c. Michelle and Alan reported that the Missouri River Recovery Implementation Committee (MRRIC) that had just met in Kansas City, MO on Oct. 30-Nov. 2<sup>nd</sup>. A big portion of the meeting was the first inperson meetings for the new Fish, Bird and Human Consideration Teams. One big consideration is the possible delisting of the least tern. More information about the meeting can be found <a href="here">here</a>. The next meeting MRRIC meeting will be held March 27<sup>th</sup>-29<sup>th</sup>, 2018.
- d. The Ag subcommittee had no report.

**Update on Drought and Flood trends affecting the Missouri Region:** Scott Watson of the National Weather Service (NWS) presented a ppt that can be seen <a href="https://example.com/here">https://example.com/here</a>. Scott went through the U.S. Drought monitor, how it works and the drought levels for the Missouri River Basin over the last 18 years. The Missouri Region falls in Climate Division 3 which shows similar drought and flood periods to the rest of the basin. The Palmer Hydrological Drought Index (PHDI) has a much more robust data set and it appears that the frequency and size of extreme precipitation events is increasing. Scott stated that the "8-10 inch rainfall events are happening more often," which results in increased flood events. When looking at major and moderate flooding there has to be considerable damage and not necessarily crop damage to make it a major flood. Some areas such as parts of KC have made considerable improvements in the levee system so the flooding isn't as damaging as in years past. Scott compared a couple major flood events 1993 vs 2011 and how the circumstances surrounding the floods were vastly different. Climate change was brought into the discussion with predicted changes in seasonal patterns due to CO² emissions, warmer and wetter for the Missouri Region. Carl asked about ground water supply and quality of surface water. Alex brought up the "Letter to Humanity" a short read that talks about climate change.

CIG Grant for Technology Farm in DP County: Chris was sick and unable to provide information on this and Tj was unfamiliar with exactly what Chris was proposing. Michelle wanted to make sure the RAC gets information on the grant and provide support if necessary. Bruce, NRCS, said the CIG grants are designed to increase technology and not just mimic existing technology from other areas of the state. There was a good deal of discussion on technology farms and the difference between farms from west to east: topography, soil types and other issues. Darcy mentioned that his company monitors 55 moisture probes some of which monitor nutrients as well. He expressed some concern about literature that documented the movement of salts and that this didn't necessarily correlate to the movement of nutrients.

**State of the Resource (SOTR):** Tj presented a brand new draft document that was smaller, more specific and easier to find information. This draft can be seen <a href="here">here</a>. The information from the previous draft will be used to update the water plan so the RAC's effort on the document will not be lost. Several sections had been removed and new tables had been added. The new draft will be sent out shortly and comments are requested. Michelle wanted to have both the pie chart and bar graph for water use put in the document. I need to add to the 2017 activities, MO River Subcommittee formed and submitted comments on the Missouri River Draft EIS. On the education goal Carl didn't think we needed a subcommittee however he would like set of 4 or 5 slides to talk about water issues in Kansas. Travis and Bruce wanted to make sure accurate information from other agencies

is included in the document. There was no meeting date or time set to hold the SOTR meeting. However Carl thought it best if we had more input from the other members on the RAC, possibly a conference call.

**Agency or Public Comments:** There were none.

Other Issues: Kansas Health Institute (KHI) Water Reuse Presentation – Tj went through a ppt provide by KHI on the Health Impact Assessment (HIA) they had completed on the reuse of water. Some of this information was presented at the Governor's Water Conference and the ppt can be viewed <a href="here">here</a>. There are reuse projects taking place statewide, some with large amounts of water being reused. For example the Spirit Corporation in Wichita is treating 2-3 million gallons of water/day for reuse. Most of the reuse water across the state is applied to ball fields, golf courses or agriculture fields. The technology is there to treat water from toilet to tap however there is still a big "yuck" factor and the cost.

**WaterOne Tour:** Mike Armstrong, General Manager from WaterOne provided the group with a ppt of the operations which can be viewed <a href="here">here</a>. WaterOne is an independent, non-profit water utility founded in 1957 serving a 272 square mile area. They have 2,600 miles of pipe and annually they have about 700 water main breaks and his goal is to have them repaired in 4 hours or less. They continue to expand and will add about 1,200 customers for 2017 and their water is some of the cheapest around. WaterOne is working on an Ozone treatment at the Hansen facility that will provide better water dissenfections. Michelle and her staff took the group a tour of the Wolcott Treatment Plan.
