- **1. Welcome and Introductions:** The meeting was called to order at approximately 9:00 a.m. Gary Koons thanked everyone for attending the meeting and Chuck Shively took roll.
- 2. Review of the February Meeting Notes: There were no corrections to the meeting notes.
- 3. Kansas Water Authority (KWA): Connie Owen, Chair of the Kansas Water Authority, addressed the committee and thanked them for their hard work. She stated that the work done by the RACs was extremally important and is committed to being an active part of the process.
- **4. Kansas Water Office Staff Update:** Angela Anderson was introduced as the new planner for the Verdigris Planning Region. Angela brings a wealth of knowledge and experience to the roll that will undoubtably serve the region well. Gary Koons will remain as lead for efforts at the CVR facility intake on the Verdigris.
- 5. Goals and Action Steps Revisions: Gary Koons (KWO): opened the meeting up to discuss the region's goals and action plans. Nate Westrup (KWO) shared his perspective on goal progress as they relate to reservoir operations and efficiencies in the Verdigris reservoir system. Guidance was given on the wording of goals and action plans based Nate's familiarity with the system and experience working with partner agencies.

The intent of goal #3 was briefly discussed and was determined that watershed structure deterioration was the concern. An update of this goal will be provided to the group for review.

- 7. Agency and Public Input: Pam Walker (Wilson County Conservation District) had questions regarding water quality impacts downstream of a proposed pilot to pass sediment through a reservoir. Gary Koons shared that others including KWO wanted to be certain this was a safe lake management practice for users downstream. Core samples of the reservoir floor and instream water quality monitoring have been made key components of the pilot's design.
