- **4. KWA April 26**<sup>th</sup> **and May 18**<sup>th</sup> **Meeting Review:** Mr. Ditmore initiated the review of the two KWA meetings by recognizing that RACs now seem to be focused more on managing the current resources and are less about building structures. He stated the meetings have been informational. Rep. Doug Blex (WRAPS) commented that the May 18<sup>th</sup> KWA meeting highlighting the opportunity to work with federal dollars was good, as well as the plan to incorporate the Vision Document into the updated Water Plan. A lot of work, time, and input went into formulating the Vision Document.
  - Angela Anderson then highlighted the agenda items discussed in both KWA meetings.
- 5. **Budget Webinar Follow-Up:** Angela Anderson briefly discussed the budget webinar that the KWO hosted in order to prepare the RACs for their budget recommendation meetings that will take place mid-summer. She directed the group that were unable to attend webinar to the <a href="KWO website for viewing">KWO website for viewing</a> when it is convenient for them.
- **6. Draft Updated Verdigris Regional Section of the Kansas Water Plan Overview:** Angela Anderson provided an overview of the draft Verdigris Regional Section that will be incorporated into the Kansas Water Plan. The RAC members provided local knowledge to be mentioned in the document, including:
  - Corn is a major crop for the region
  - Wind energy facility is now present
  - Brine issues from abandoned wells are a priority for the Toronto and Fall River WRAPS projects
  - Deer hunting recreation has increased in the region which has led to significant dollars for agricultural operations
  - Osage Aquifer is not a term; it is now classified as the Douglas Aquifer
  - The region, specifically Coffeyville, continues to see the impacts on streambanks from the 2007 flood which was bigger than a 500-year flood
- 7. **Membership Discussion:** Angela Anderson highlighted the upcoming call for membership to the Regional Advisory Committees, listing the position that is vacant the Public Water Supply category, which is a core category.
- 8. Questions and Future Issues from RAC Members:
  - Angela Anderson posed the question before the RAC members as to how they prefer to meet for future meetings, with any in-person meetings always having a virtual option. Members thought that meeting in person at least 2 times per year would be preferable.
  - Doug Blex (WRAPS) stated that he was very proud of the Verdigris RAC for their impact on statewide goals as one of the region's goals and action plans was deemed important enough for a statewide goal.
- 9. Agency Input:
  - Katie Tietsort (KDA-DWR): The agency will continue to need at least a hybrid option in order to attend RAC meetings. Upcoming guidance on opening the office June 13<sup>th</sup> will be delivered to their personnel soon. As of present, there is only one person in the office until June, but there continues to be a lot of field work being done. Caleb Fabryky took a new job in Parsons; his position is now open. Their office is working to get water right files scanned.
- **10. Public Input:** There was no public input.
