## **City of Council Grove Water Marketing Contract Application and Request to Negotiate**

In accordance with K.S.A. 82a-1310a, on Dec. 6, 2018 the City of Council Grove submitted a Water Marketing Contract Application for an annual quantity of 175 MGY from Council Grove Lake. A copy of the application is attached to this memorandum. On January 3, 2019, the Kansas Water Office received a request from the City to begin negotiations.

The City has an existing marketing contract (No. 93-4) with a graduated use schedule and maximum annual quantity of 150 MGY with an end date of Sept. 13, 2033.

*In accordance with the State Water Plan Storage Act, K.S.A. 82a-1301 et seq., the Director of the Kansas Water Office requests approval from the Kansas Water Authority to enter into negotiations with the City of Council Grove for a contract to withdraw and use water from Council Grove Lake for the purposes of serving the City of Council Grove.*

## **City of Lawrence Water Marketing Contract Update**

Contract negotiations continue between the Kansas Water Office and the City of Lawrence. Prior to finalizing the City's new contract quantity, the Kansas Water Office and the City will host a meeting with the water marketing customers from Clinton Lake on February 6, 2019. It is anticipated that a draft contract will be ready for review at the April KWA meeting.

## **Kansas Water Office Bathymetry and Storage Evaluation Program Update**

In 2019, the Kansas Water Office will launch the Bathymetry and Storage Evaluation (BaSE) program to increase the rate of bathymetric data collection for Kansas water supply reservoirs as recommended by the Kansas Water Authority in the 2010 Kansas Reservoir Roadmap. In many Kansas basins, model simulations show that in the coming decades, reservoir storage will be insufficient to meet demands through drought conditions.

Reservoir sedimentation is a major driver in our ability to meet future water supply demands, with many Kansas public water supply reservoirs having less than 3 surveys over their 40-70 years of operation for the establishment of long term sedimentation rates. Additional reservoir data will help to reduce uncertainty related to historical sedimentation rates, refine water supply projections and planning for the future, and will be beneficial to identifying the impacts of in-basin practices on sedimentation rates. The BaSE program will allow for an increased frequency in bathymetric surveys, creating robust trends of sedimentation rates in reservoirs, as well as an increased confidence in both current and future reservoir storage capacities.

The KWA RAC Operations Committee met on January 24, 2019, via conference call. Discussion from the meeting included a message to the KWA from the Missouri Regional Advisory Committee from their most recent meeting. This RAC message to the KWA, along with pertinent background information, KWO staff input, and proposed resolution are included in this memo.

**Message:** The Missouri RAC requests funding to complete year two of Phase II of “Addressing Groundwater Goals of the Missouri Regional Planning Area” by the Kansas Geological Survey (KGS). Funding of the study would provide information directly related to Missouri RAC Goals #1 & #3.

**Background:** In March 8, 2018, the Kansas Water Office (KWO) entered into a five year contract on Phase II with KGS to document historical ground water quality and quantity for the Missouri Region. KGS scoped the entire study however only the first year of the contract was funded. Geoff Bohling and Don Whittemore reporting their initial findings to the RAC at the September 20th meeting, continuation of the study was recommended. The complete first year report is due in March 2019. The quantity of water in the unconsolidated material remains undetermined as well as water quality issues, especially nitrates in the groundwater. The drought of 2018 showed just how fragile the groundwater situation is in the Missouri Region. Multiple private domestic wells have ceased to function, low flows in streams and high nitrates have caused conflict between neighbors and communities with the ever expanding irrigation industry in the region. More information, certainty about safe yields and water quality will help mitigate these conflicts. The projected cost for year two of the study is \$38,000. This funding will be used to continue the water quantity and quality monitoring and analyses that began in year one and to install sensors and telemetry for continuous, real-time water level monitoring of the five existing wells.

**Staff Input:** Staff contacted Geoff Bohling (KGS) to discuss the study. KGS has identified ten (10) USGS wells in the region, and attempted to measure water levels and sampled water from these wells in August of 2018. Staff will return for repeat measurements in February 2019. Many of these wells are not in the aquifer material and do not represent the aquifer in the region. The existing wells are insufficient to provide any type of trend data or regionally based data to use for making management decisions. Also, this project helps to further advance Vision Regional Goal Action Plan implementation efforts for Missouri RAC Goals 1 & 3. With this project being multiple years and phases and directly connected to Action Plan implementation there is justification to continue funding support for these efforts.

**Proposed Resolution:** The KWO is committed to working with the KGS on advancing year two of Phase II “Addressing Groundwater Goals of the Missouri Regional Planning Area”.

As previously presented and discussed by the Kansas Water Authority (KWA), a research coordination workgroup has continued to meet to identify priorities for research needed to support implementation of the Vision. No action is being sought at this time.

Efforts focused on the specific areas of research previously identified by the group have continued, which include streambank stabilization effectiveness, irrigation technologies and crop genetic research, and harmful algal blooms. Sarah Sexton-Bowser will update the KWA on ongoing efforts within the irrigation technologies and crop genetic research subgroup, focusing specifically on sorghum research.

The development of a Water Research Newsletter, *Research on Tap*, continues. KWO will compile ongoing water-related research from universities and disseminate the newsletter once a quarter, which will also be posted on the Water Research Coordination Workgroup webpage on KWO's website.
