
Federal Reservoirs

- Federal Authorization
 - Flood Control Acts of 1944 & 1954
 - Water Supply Act of 1958
 - Authorized inclusion of water supply storage
 - Required assurances of need and acceptance of financial obligation from the State of Kansas
- The Kansas Constitution
 - Amended in 1958 to authorize the state to participate in works for the conservation and development of water resources
- The Legislature of the State of Kansas by House Concurrent Resolution (Chapter 479 of the Session Laws of Kansas of 1961)
 - Notified the United States Army Chief of Engineers that the state would fulfill these obligations
 - Initial water supply requests for Milford, Perry, John Redmond, Elk City, and Council Grove reservoirs

State Framework (Storage)

- State Water Resource Planning Act (1963)
 - KWO (Kansas water resources board) authorized to recommend water supply inclusion and contract for storage with the federal government
 - 82a-929. Same; state responsibility for water. The state of Kansas hereby recognizes its responsibility and jurisdiction to protect, conserve, and <u>control all waters affecting</u> the people of the state, including those waters impounded in projects constructed <u>pursuant to programs of the federal government</u>.
- State Water Plan Storage Act (1974)
 - Water reservation rights (acquired by the Director)
 - Water Marketing Program
 - Water purchase contracts, direct withdrawal or downstream
- Water Assurance Program (1986)
 - Supplemental downstream support to Municipal & Industrial water rights
- Lower Smoky Hill Water Supply Access Program (2011)
 - Supplemental downstream support to Mun/Ind/Rec/Irr water rights


Public Water Supply Reservoirs








In-Service Storage vs Future Use




