b. **State Budget Update Presentation:** Earl Lewis, KWO Director, provided an update on the recent changes to the SWP FY22 budget requests as well as summary of the past funding utilized in the Cimarron region.

5. Regional Activities

- a. **Budget Discussion & Recommendations:** A memo was drafted indicating that the Cimarron RAC recommends funding priority towards the Water Technology Farm program, technology efforts with KDA-DOC, and supporting the GMD3 groundwater model GUI interface in the Cimarron Region. A motion was made by Trista Brown Priest and seconded by Jim Sipes to forward this memo on to the KWA.
- b. **RAC Goals & Action Plans Update Recommendations:** Upon further discussion, draft revisions to goals #1 & #2 were made to include additional action items. As well, goal #3 was revised to encourage more conservation amongst users; which also incorporated additional action steps. There was a motion by Luke Grubbs and seconded by Matt Higgins to forward these draft revisions to the KWA for final approval of updating the Cimarron RAC goals and action plans.

6. Other Business

- a. Agency Reports
 - **i. KWO:** Armando provided an update on status of KWO to include that most employees are still teleworking and are under instruction to continue to hold virtual meetings. Armando also mentioned that the next KWA meeting will be held on August 24th. Lastly, Armando noted that the KS Governor's Water Conference will not be held in person this year but will still be available to attend virtually.
 - **ii. KDA-DWR:** Mike reported that their office is fully functional but not open to in-person meetings at this time. He also reported that any late water use report fees are not at \$1,000.
 - iii. KDA-DOC: No reports at this time.
 - **iv. GMD3:** Jason stated that the GMD3 office is open for business, they have also initiated their summer meter reading program, and are in the process of executing their POC project.
