### Regional Activities KWA/RAC Business

Advisory Committee Membership: Diane Knowles reviewed the changes in committee membership and actions by KWA to appoint and reappoint committee members. Mark was appointed as vice chair by chairman of KWA, Gary Harshberger. KWA appointed Gene Albers to vacant agriculture position in May. In August KWA made reappointments of Suzanne, Mark, Jim, and Jay; and appointed Jeff Porter to fill local government, vacated by Amber's resignation.

KWA has held two meetings, May and August since the RAC meet. Mark Watts reported to KWA for the Region in May on local activities. Mark provided a review of the tour associated with the meeting where water technology farms and a new LEMA were some of the highlights. Diane noted the August KWA meeting included an opportunity for RACs representatives to meet. Discussion among the chairs and KWA members involved implementation frustration and achievements.

State of the Resource annual reports were discussed by Diane Knowles. These reports will be developed by staff and discussed by RACs in October. One use of the report on water resources, activities and needs in the region will be for outreach in the region. Suggestions for use of the information included annual meetings of county conservation districts and conservation district newsletters.

# Red Hills Regional Advisory Committee Meeting Notes

FY2018 KDA-DOC County Allocations: No report

**Lake Goal update:** Mark Watts reviewed the status of the Lake project. The Sunflower H2O work group has identified the need for investors for the project since it is envisioned as a multipurpose lake. To pursue this Tracy Streeter and Mark have meet with Tim Austin to begin creation of a model for development/investment for a lake for recreation, some water supply and flood control. The committee was reminded that the parameters for the lake need to be determined in order to proceed with an engineering study.

## **Produced Water Pilot Project:**

Diane updated the committee on the work to actually receive the grant funds from the Bureau of Reclamation. More work is still needed on the budget and costs for equipment.

Related to produced water, Diane provided a summary of the joint RAC (4 RACs) meeting on low quality water held in July. Ken, Mark and Larry attended from the Red Hills. Both Mark and Ken noted they came away with better understanding of available information and appreciated the networking.

Water Technology Farms 2017: Richard Rockel provided overview of the existing WTFs and described the process to get one established. There was discussion of the general concept as well as specific technologies, comparisons being used and studied, cost-share availability, state assistance and possible ideas for a WTF in the region. Possible study areas included crop rotation, cover crops, soil health, evaporation and cotton.

Irrigation-Dragon Line presentation was made by Braden Deyce covering basics of the new technology. Extended discussion addressed producer questions, benefits of the system and general cost.



Day 1 Speakers this year will focus on federal regulation processes and as well water infrastructure. EPA Administrator, Scott Pruitt has been invited as the keynote.


The Water Legacy Award recipient will also be honored on Day 1. This individual will be selected based on significant contributions and lasting impacts on the future of water in the state.
