- 1. <u>Welcome and Introductions:</u> The meeting was called to order by RAC Chair, Holly Dickman (Large Public Water Supply) at 9:03am. She then allowed each meeting attendee to provide a brief introduction.
- **2.** Review of July 2023 Meeting Notes: The meeting notes from the previous meeting were reviewed. Brad Shogren (Irrigation) made a motion to approve the notes with the aforementioned change. Baron Shively (Conservation/Environment 2) seconded the motion. The meeting notes were approved with no further additions or changes.

- **a. RAC member introductions:** Time was taken to allow the new members to provide introductions of themselves to the RAC. The newly appointed members include Lon Schrader (At Large Public), Jay Leusman (Agriculture 3) and Herb Graves (Conservation/Environment 3). After the new members, all other RAC members were given a chance to provide introductions.
- a. Discussion of Hays R9 Transfer: This discussion began by Matt Unruh (KWO) giving a brief background to the group about the context for this topic and the discussion today. He noted that at the previous KWA meeting, the KWA requested feedback from the Smoky Hill-Saline and Great Bend Prairie RACs regarding the proposed transfer. Then, a presentation from Toby Dougherty with the City of Hays and Jon Quinday with the City of Russell was given followed by a brief comment by Orrin Feril with GMD 5 and a presentation by Pat Janssen with WaterPACK. The RAC members then discussed and asked questions to the representing parties present. The RAC then determined they would provide feedback to the KWA. A general consensus was reached that this feedback accurately captures the feelings of the RAC members regarding the transfer. No official motion or vote was taken.

"The Smoky Hill-Saline Regional Advisory Committee (RAC) would like to pass the following feedback to the Kansas Water Authority Budget Committee for consideration.

- The RAC recognizes the commitments, both financially and over time, that the cities of Hays and Russell have put forth towards this process
- The RAC desires to ensure that the allocation numbers and data are accurate to ensure sustainability into the future
- The RAC encourages all parties to continue open discussions
- The RAC would like to acknowledge that all parties involved are willing participants and eminent domain was not used for the purchase of the land and associated water rights of the R9 Ranch"
- **b. KWO/KWA Updates:** Amelia informed the RAC that at the previous KWA meeting, the KWA approved the proposed FY25 budget. She stated that she would send the budget table out to the RAC. Additionally, Amelia reminded the RAC of the Governor's Conference that is coming up on November 15 & 16 and said that registration is currently open for the event.
- c. Discussion of regional events: No regional events were shared at this time.

4. Agency or Public Comments:

- **a.** On behalf of Stacie Minson (K-State Research & Extension) Amelia Nill shared that the next Smoky Hill SLT meeting is to take place on Tuesday, October 3rd and that RAC members are welcome to attend. Also, she shared that K-State Research an Extension puts out a newsletter to the public and that if any RAC member is interested in receiving the newsletter by email, they could.
- **b.** Jennifer Nichols (KDHE) told the RAC that they received budget enhancements to address local septic improvements. Additionally, she stated that there is currently a need for mineralization studies throughout the state. And finally, she mentioned that money has been allocated specifically for small municipalities use.
