- **I) Welcome and Introductions:** The meeting was called to order at 2:06pm. Each person in attendance proved a brief introduction.
- **II**) **Review of February 2nd meeting notes:** The meeting notes from the February 2nd Kansas RAC Meeting were review. Leslie Holthaus (Conservation/Environment) made a motion to approve the notes. Sarah Hill-Nelson (Industry/Commerce) seconded the motion and the notes were approved with no additions or changes.

III) RAC Business:

a. Discussion of KWA Strategic Planning: Connie Owen (KWO) described the discussion that transpired at the April KWA meeting regarding the Strategic Planning efforts charged by Governor Kelly. She stated that the KWA had developed 3 overarching goals to drive the efforts

moving forward. These goals cover water quality, the High Plains Aquifer and reservoir planning generally. Within these goals, with the help of agency partners, other stakeholder and local and RAC input, specific action items will be identified. She explained to the RAC what the process of collecting the local and RAC input will look like. Connie stated that local consult meetings, that will be open to the public, will take place first in the earlier part of the summer. Then, the RACs will have the opportunity to provide their input directly to the KWA in the later part of the summer. Connie said that this is a process that is being developed as it is happening, so there might be further changes to the process.

- **b. Discussion of RAC Subcommittees:** The RAC decided to table this discussion until a later meeting.
- **c.** Legislative Update Amelia Lane (KWO) reviewed the memo from Victoria Asbury (KWO) regarding items of importance from the Legislature. The main item from the memo was the Governor's proposed budget, which mirrors what the KWA proposed with minor changes. She highlighted the potential extra \$1 million that could go towards the HB2302 grant programs.
- **d. BMP Directory Review** Katie Goff (KWO) shared the newly published interactive BMP Directory site. This interactive site was developed using the BMP Directory originally formed by the Kansas RAC. The interactive site now includes statewide programs and will continue to expand as feedback is received. She explained to the RAC how it can be used and asked if RAC members had and immediate feedback on it.
- e. KWO/KWA Updates: Amelia Lane informed the RAC of the progress for the first round of the HB 2302 Grant Programs. She mentioned that there is an interactive tool on the KWO website that provides further details on the applicants and projects funded in this grant cycle. Amelia shared that the KWO has two new hires, Riley VandeVen as a Regional Planner and Amy Green as an Administrative Specialist. She also brought up the 2 PAS Agreements discussed at the previous KWA meeting. The first being an agreement for the Coffeyville Resources low-head dam and the second being for an agreement with the USACE for reservoir sustainability and water quality.
 - June 11th KWA Meeting Preparation: The Kansas RAC Chair is set to provide a brief presentation to the KWA at their upcoming meeting in June. RAC members shared a few topics that should be highlighted in this presentation. Further discussion regarding this presentation will take place at the Kansas RAC's next meeting in late May.
- **f. RAC Member Updates & Regional Event Sharing:** Each RAC member shared current, important items regarding the RAC category they represent.
