HB 2302 Grant Programs FAQ

Application Logistics

- 1. Do previous applicants have to resubmit their applications? Yes.
- When should I start my project timeline?
 Applicants should build their timelines with a start date of January 2025.
- 3. Can I include more information in the Project Plan and Objectives section than the paragraph summary and tables shown in the template?

Yes. The tables and paragraph should be considered a cover page/summary to your full project description of the water infrastructure project for which funds are being requested, including a project timeline and sufficient professional documentation of cost estimates.

4. What is an affidavit and what does it need to say?

An affidavit is a notarized document providing sufficient assurance that (1) the applicant has acquired, or at least applied for, all federal, state and local permits that may be relevant to their proposed project and (2) they have acquired legal access to all property necessary for their proposed project. The affidavit should contain a very brief statement that includes:

- Applicant's name.
- Title of the proposed project.
- County or counties in which the project will be located.
- Statement that the applicant has acquired, or has applied for, all
 necessary federal, state and local permits and a statement that they
 have acquired all legal access to the property needed for purposes of the
 proposed project.

5. What if I have more than one qualifying project? Can I submit more than one application?

Yes. An entity can submit applications for multiple projects for the Technical Assistance Grant, the Water Projects Grant, or a mixture of the two. Each project requires its own application.

6. Can I apply for the Technical Assistance Grant and the Water Projects Grant for the same project at the same time?

Yes. However, it should be noted that projects with earlier timelines will be prioritized when awarding the Water Projects Grant. Therefore, a project may receive a Technical Assistance Grant, but not a Water Projects Grant in the same award cycle.

Is it possible for partial grants be awarded?
 HB 2302 does allow the Kansas Water Office to award partial grants.

Qualifying Projects

8. What kinds of projects qualify for the grants?

Both grants relate to "water infrastructure projects" or "water-related infrastructures". Water infrastructure and water-related infrastructures are not defined in statute, meaning that projects related to both hard infrastructure and green infrastructure may qualify. We encourage you to apply with all types of projects related to water infrastructure.

- Do wastewater, stormwater, or drinking water projects qualify?Yes.
- 10. Can these funds be used for active projects? For example to meet overages on construction bids that came in over budget or have stretched beyond the original timeline, creating additional costs?

Yes. We understand that the current conditions have caused supply chain issues and rising costs among other issues. We hope these funds could assist small communities with these rising costs and help to complete a project, even in an active construction phase.

11. Can funds be used to reimburse for past projects?

No, a project must be active/ongoing or planned for the future at the time of award to qualify.

12. Is there a date the project must be completed by in order to qualify for the grants?

There is no completion deadline in order to qualify for the grants. However,
quarterly reporting is required to ensure progress is being made and funds are
being used for eligible costs.

Eligible Expenditures

13. Can funds be used for contractors or consultants?

Yes. We anticipate most awardees for both grants to utilize contractors or consultants in their technical assistance or construction projects.

- 14. Can the Technical Assistance Grant be used for a preliminary engineering report?

 Yes.
- 15. Can the Water Projects Grant Fund be used for design/planning?

No. Statute states that the Water Projects Grant Fund may be used for "construction, repair, maintenance, or replacement of water-related infrastructure and other construction related costs". These programs do not consider design/planning as a construction related cost. A Water Projects Grant applicant should be ready to "break ground" as soon as funds are awarded.

16. What is meant by design/planning?

Any preliminary engineering, planning, conceptual design, or detailed design should be applied for under the Technical Assistance Grant, not the Water Projects Grant.

- 17. Are grant administration costs allowable expenditures for either grant?

 Yes. Up to 15% of requested funds for either grant may be used for grant administration costs. Grant administration costs do not include costs to submit the initial application. Examples of allowable grant administration costs include time to complete required reporting documents.
- 18. The Interim Guidelines state that the Technical Assistance Grant can be used for "processing grant and loan applications". Does this mean funds can be used to reimburse a grant consultant for applying for that Technical Assistance Grant?

 No. The Technical Assistance Grant can be awarded to provide funds to hire a grant consultant to apply for future outside grants, such as federal grants.
- 19. Can the Water Project Grant be used for payoff USDA loans?
 No, only loans through KDHE's Public Water Supply Loan Fund and Kansas
 Pollution Control Fund are eligible for the Water Projects Grant Fund.
